# **STEARNS SALES PORTABLE RESTROOM AGREEMENT**

---

- RENTER MUST PAY THE REMAINING BALANCE OF THE RENTAL AGREEMENT BEFORE THE DATE OF DELIVERY, OR THE UNIT WILL NOT BE DELIVERED AND THE RENTAL DEPOSIT WILL NOT BE RETURNED
- RENTER AGREES TO TAKE RESPONSIBILITY FOR ANY DAMAGE DONE TO THE RESTROOM AND WILL LOSE THE DAMAGE DEPOSIT, AND AGREES TO COVER ANY EXTRA COST OF DAMAGES THAT THE DAMAGE DEPOSIT DID NOT COVER. IF STEARNS SALES AND RENTER AGREE TO NO DAMAGE, THE DAMAGE DEPOSIT WILL BE RETURNED. RENTER MUST COME BACK DURING BUSINESS HOURS TO GET DAMAGE DEPOSIT RETURNED
- THERE IS ONLY ONE CLEANING AND ONE PUMPING OF RESTROOM INCLUDED IN PRICE OF RENTAL UNLESS OTHER TERMS AGREED UPON. THIS IS DONE WHEN THE RESTROOM IS READY TO BE RETURNED TO STEARNS SALES. ANY EXTRA CLEANING OR PUMPING OF THE RESTROOM WILL BE CHARGED TO THE RENTER. IF RESTROOM REQUIRES AN ADDITIONAL PUMPING, RENTOR WILL BE CHARGED ACCORDINGLY, AND COST WILL BE DEDUCTED OUT OF DAMAGE DEPOSIT. BALANCE OF DAMAGE DEPOSIT WILL THEN BE RETURNED IF UNIT IS RETURNED WITH NO DAMAGE.
- RENTER HAS UP TO 15 DAYS BEFORE THE DELIVERY DATE TO CANCEL THE RESERVATION OF THE RESTROOM AND GET A FULL REFUND OF THE DEPOSITS. AFTER THE 15 DAYS, THE RENTER WILL NOT GET A REFUND OF THE DEPOSITS.

- RENTER MUST PROVIDE A FLAT AREA FOR RESTROOM, MUST BE WITHIN 50 FEET OF ELECTRICAL OUTLET, AND 100 FEET FOR A WATER CONNECTION
